Inconsideration of being allowed to participate in any way in the Curwensville Lions Club (Kayak/Canoe) Poker Float

I, as participant (the Releaser), hereby acknowledge, appreciate and agree that:

1. The risk of injury from the activities involved in this program and while particular skills, equipment, **MUST HAVE A LIFE PRESERVER AND WHISTLE** and personal discipline may reduce this risk, the risk of injury does exist; and
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE CURWENSVILLE LIONS CLUB (THE RELEASEES) or others, and assume full responsibility for my participation; and
3. I willingly agree to comply with the stated and customary term and conditions for participation. If, however, I observe any significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the Releasees; and
4. I, for myself and on behalf of my heirs, assignees, personal representatives and next of kin, HEREBY RELEASE, INDEMINIFY AND HOLD HARMLESS THE CURWENSVILLE LIONS CLUB, AND OR CURWENSVILLE COMMUNITY CENTER (land leasee) their officers, officials, agents, and other participants, and if applicable, owners and lessors of premises used for the activity WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with my presence or participation, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law, and
